- CFP^m Exam
- * Books and/or other related materials may be covered as well. Travel expenses will not be covered.
- ** The amount of the scholarship awarded will be equal to the actual cost of a Review Class or Exam up to the allowed amount.
- ***The scholarship must be used by the end of 2018.

Eligibility: In order to be eligible for the scholarship, all of the following must be met:

- Is exempt or has completed all required courses for the CFP® Board of Standards certificate examination.
- Has intention to take CFP* test and become a CFP* designee.
- Is, or will become, a member of the Financial Planning Association of Central VA. If not currently a member, applicant must be sponsored by an existing member.
- Demonstrates academic accomplishments; i.e., GPA and degrees received as well as professional and/or community involvement.
- 5. Furnishes the following:
 - a. Completed application
 - b. One letter of support from either a professor or practicing CFP® professional
 - c. Resume
 - d. Short essay (500 words or less) indicating reason(s) for wanting to become a
 Certified Financial Planner™
- Willing to attend award ceremony and/or have a public announcement made regarding the scholarship.
